With the rural dividend fund suspended, this could be a viable alternative funding option for trails development and maintenance in your community.

Good Morning UBCM members:

On behalf of Chair Art Kaehn, UBCM's Electoral Area Representative and Chair of the UBCM Community Economic Development Committee, I am reaching out to you since you, or your community, have previously been part of the UBCM's Off Road Vehicle (ORV) working group; or your contact information has been provided to UBCM by Kim Smith at ATVBC.

In March 2014 the ORV Act was passed, over five years ago. And while the legislation responded to UBCM member concerns related to regulating and licensing of ORVs we understand that some communities have concerns about some limitations related to trail access/connectivity. UBCM has also received three resolutions related to operation permits for consideration at this year's Convention. As a result, UBCM felt it was timely to check back in with interested members, provide an overview

of the existing rules and regulations and hear from affected communities about some of the concerns related to implementation and economic development (tourism) interests as it relates to ORVs.

Vera Vukelich, Manager, Land Policy and Programs of the Ministry of Forests, Lands and Natural Resource Operations and Rural Development is the provincial staff person that has supported the ORV file since its inception. We would like to arrange a conference call with interested local governments and Vera to provide you with an opportunity to learn more about the background to the ORV Act but also give you a chance to share your questions and concerns with Vera.

I am writing this as a member of the Oscar Hickes Memorial Hockey Tournament organizing committee.

As you are no doubt aware, this tournament has been successfully held for the past 40 years. This coming edition would mark the 41st anniversary of what has become the longest running tournament of its kind on Vancouver Island.

Although it is a tournament for adult hockey players, this tournament represents the major source of fundraising for the various youth groups participating. These groups include (but are not limited to) the Port Alice Minor Hockey Association, Henry Penny Pre-school, youth soccer, and Dry Grad.

Over the duration of this tournament, we estimate that the total funds raised are well in excess of \$300,000. This does not include the associated revenue generated by the various businesses in Port Alice directly and the rest of the North Island in general.

We are writing this letter to ask the following question:

If the Port Alice Arena Society pays all the costs (to be determined) for the installation and removal of the hockey ice plus associated arena operating costs, would the Village of Port Alice agree to allow the 41st Annual Oscar Hickes Memorial Hockey Tournament to be held March 27th through March 29th, 2020?

Re: Appointment to the 2020 Vancouver Island Regional Library Board

It is time to consider your 2020 representation on the Vancouver Island Regional Library (VIRL) Board of Trustees. VIRL is the fifth largest library system in British Columbia serving more than 457,000 residents on Vancouver Island, Haida Gwaii, and Bella Coola on the Central Coast. VIRL enhances lives through universal access to knowledge, lifelong learning, and literacy in the communities we serve.

When appointing your representative, the *Library Act* (October 9, 2019), section 17 (2) states:

"All subsequent regular appointments must be made each November at the first meeting of the municipal council or regional district board."

The term of office is one year, January 1 to December 31. Reappointment of sitting members is encouraged for continuity, but no member may serve for more than 8 consecutive years.

The *Library Act*, section 55, reimbursement of expenses states: "(1) The members of a library board are not entitled to be paid by the library board for their services but may be reimbursed by it for reasonable travelling and out of pocket expenses, including child care expenses, necessarily incurred by them in performing their duties under this Act. (2) A library board may not reimburse a member for any expenses if another body reimburses the member for the expenses or pays the expenses.

VIRL requires annual documentation by December 16, 2019 for both your appointed VIRL Trustee and Alternate, including:

- 1. Certified copy of the Resolution (by provincial legislation)
- 2. Financial disclosure statement (original or copy of that on file with the municipality/district)
- 3. VIRL 2020 Appointment form

RDMW Noxious Weed Control Program

The Regional District of Mount Waddington has been operating a Noxious Weed Control Program for the last five years. The main focus of the program has been knotweed eradication. The program has been funded through a grant from the Ministry of Social Development and Poverty Reduction and small contributions from the communities who have participated in the program. In 2019 the program sent a crew to Port Alice for five days for knotweed eradication. The Village of Port Alice did not contribute any funding to the program in 2019.

The Regional District of Mount Waddington has advised that the grant funding will no longer be available for the program after this year. They would like to continue the program and at a meeting on October 30, 2019 presented a funding model based on higher contributions from participating communities and a contribution from the RDMW solid waste budget.

The amount that would potentially be requested from the Village of Port Alice for the program would be \$2,700. This funding would give us five days of eradication as well as producing the required reports to the Province.

If Council is interested in continuing this service with the Regional District of Mount Waddington the expense could be added to the 2020-2025 Financial Plan.

Reconsideration of Motion

At our last Council meeting Motion # 118/19 regarding cancelling the Council wage subsidy for 2020 was passed. As per our Procedure Bylaw "A motion that deals with a matter that is not on the agenda of the Council meeting at which the motion is introduced may be introduced with Council's permission".

Sometimes when a motion is introduced without a backup report or an opportunity to think about it Council members will vote and then change their mind later. Our procedure bylaw addresses this with the following:

Reconsideration by Council Member

- 25. (a) Subject to subsection (e), a Council member may, at the next Council meeting,
 - (i) move to reconsider a matter on which a vote, other than to postpone indefinitely, has been taken, and
 - (ii) move to reconsider an adopted Bylaw after an interval of at least 24 hours following its adoption.
 - (b) A Council member who voted affirmatively for a resolution adopted by Council may at any time move to rescind that resolution.
 - (c) Council must not discuss the main matter referred to in subsection (a) unless a motion to reconsider that matter is adopted in the affirmative.
 - (d) A vote to reconsider must not be reconsidered.
 - (e) Council may only reconsider a matter that has not
 - (i) had the approval or assent of the electors and been adopted,
 - (ii) been reconsidered under subsection (a) or section 131 of the Community Charter,
 - (iii) been acted on by an officer, employee, or agent of the Village.
 - (f) The conditions that applied to the adoption of the original Bylaw, resolution, or proceeding apply to its rejection under this section.
 - (g) A Bylaw, resolution, or proceeding that is reaffirmed under subsection (a) or section 131 of the Community Charter is as valid and has the same effect as it had before reconsideration.

In regard to Motion #118/19 there was some concern, therefore I recommend the following motion:

THAT Motion #118/19 "That for the Year 2020 Council agrees to cancel the reimbursement for lost wages policy in regard to attendance at meetings, training or conferences for Council Members" be reconsidered.

Proclaiming November as Adoption Awareness month is not the only way your community can support adoptive parents and those who might choose to adopt in the future. In addition to your proclamation, you could organize an information session for prospective parents in your community or a celebration for those who are already adoptive parents. <u>Adopt BC Kids</u> is an online portal that allows citizens to complete an adoption application 24 hours a day, seven days a week. I encourage you to take the time to explore this resource and provide it to any community members who are interested in adopting a child in foster care.
