Re: Emergency Support Services Modernization:

Dear Chief Administrative Officer:

As you are aware, the Province is committed to implementing lessons learned from the 2017 and 2018 flood and wildfire seasons and adopting the United Nations' Sendai framework for Disaster Risk Reduction. In doing so, BC is changing the way we approach emergency management. In support of this shift, Emergency Management British Columbia (EMBC) is modernizing the *Emergency Program Act*, enabling us to work together to implement the legislative changes needed moving forward.

Since the release of the *Emergency Program Act* discussion paper on October 28, 2019, EMBC has received a great deal of helpful feedback on the proposed policy changes. In the Spring we will be publicly releasing a "What We Heard Report".

Ensuring that the needs of the citizens impacted by emergencies are supported is a priority for EMBC. As part of the Province's modernization of the broader emergency management system, EMBC is working to modernize the Emergency Support Services (ESS) Program. The ESS Modernization Project aims to ensure that evacuated individuals can access services more easily and efficiently, while enhancing administration, reporting and financial accountabilities at all levels of government. Initiated in 2018, phase one of the project included; rebranding of the program name from Emergency *Social* Services to Emergency *Support* Services to reflect feedback received from local governments; an increase to evacuee meal per diems; policy amendments; and most notably, the development of a digital registration and referral proof of concept that was successfully piloted in four communities over a six-month period during Spring/Summer of 2019.

Phase two of the project continues to build on the work from phase one, recognizing the importance of engagement at every step and the value of collaborative and transparent processes. ESS Modernization components have been broken into packages to be implemented as appropriate by your community Emergency Program and/or Emergency Support Services Program.

Packages includes the following:

- Program Branding New Provincial Emergency Support Services Logo and program vision statement;
- Technical Planning Information Pilot Community feedback and recommendations;
- ESS Modernization Survey; and
- The Path to ESS Modernization.

Re: Emergency Support Services Modernization

Phase two will have a large focus on the development and provincial implementation of the online Evacuee Registration Assistance (ERA) tool to be rolled out through to Spring 2021. The ERA tool will be developed and implemented in a phased approach, enabling communities to realize the benefits in real-time as they become available. Starting in April 2020, the ERA tool will have the functionality to support: evacuee self-registration, digital registration and referrals, and basic reporting. Increased functionality will be developed and implemented, including; a *Vendor Portal* improving the process and time for ESS vendors to be reimbursed. The final development and implementation in Spring 2021, will shift the method of ESS support delivery to empower evacuees to make decisions to best support themselves during an evacuation and will include direct payment options to vendors and to evacuees.

EMBC understands that it may not be feasible for all communities to implement the ERA tool and will be rolling out implementation and training in a phased approach. In order to develop an informed provincial implementation and training strategy, we are asking all Local Authorities and First Nations to have their Emergency Program Coordinator, or person responsible for their Emergency and or ESS program, complete the ESS Modernization Survey. The survey link and instructions are included in the attached package. This information will be used to inform the development of the provincial implementation plan that will be shared with communities in the Spring of 2020.

The work being done at all levels of government to modernize Emergency Support Services programs represents a significant step forward in modernizing Emergency Management in British Columbia.

BRANDING INFORMATION FOR THE EMERGENCY SUPPORT SERVICES PROGRAM

Following the 2017 and 2018 response season, Local Authorities, First Nations and the ESS community provided feedback about the ESS program branding and identity. As a result, the program was officially renamed "Emergency Support Services" on April 1st, 2019. The intention was to remove the perception of 'social services' while simultaneously increasing awareness of basic needs and supports administered on a temporary basis via the ESS program.

Approved Logo

The following is the approved logo that can be used by local ESS programs throughout the Province. There is no requirement for local teams to adopt the Provincial ESS Program logo. EMBC will be utilizing the logo on all newly developed material going forward.

ESS Program Vision

To support the updated program name and logo, EMBC worked with a variety of partners to develop the program vision.

Emergency Support Services is a Provincial Program delivered by Local Authorities and First Nations that meets the basic needs of British Columbians impacted by disasters by providing short-term support in a compassionate manner.



Extra chargers and power bars (including battery operated) are recommended.

Community Emergency and ESS Plans should be adjusted to consider use of IT. This includes determining connectivity in pre-identified RC/GL locations and data coverage in core and outlying community areas. The plan should also establish procedures for tech support from their Local or First Nations Government.			
 ESS Teams develop standard operating procedures for callouts including who will keep and update IT devices, how they will be signed out and how they will be secured when used in the field. 			
Local and First Nations Governments are responsible to purchase hardware to support ESS response within their jurisdiction. Communities are encouraged to apply for the Community Emergency Preparedness Fund Grant administered by the Union of British Columbia Municipalities. The Provincial Government, through EMBC, may make available additional laptop computers as surge support. These can be accessed through a resource request through the British Columbia Emergency Management System.

Hi Tanya,

I am working with MW Literacy Now to help bring together a table of representatives from our region to discuss displaced workers and the impact on them and to the larger community. I would like to invite a representative from the Port Alice town counsel to join the table. Please let me know your process on how to proceed. I have copied our invitation letter below. Our regional meeting that I will co-host in partnership with SRDC and Decoda Literacy will be on March 5th in Port McNeill.

The Region of Mount Waddington was selected to be part of a federal study of Displaced Workers and we are inviting a representative from your organization to be part of the local Project Outreach Team.

Objective: the project aims to fill knowledge gaps on what works for Literacy and Essential Skills (LES) support and training for displaced workers to improve their employability. The project will seek to enhance knowledge and raise awareness of promising LES service responses to workforce displacement for individuals and communities in Canada.

Who are displaced workers: people whose lives and work have been disrupted by employment loss through circumstances like industry slowdowns, mill closures, natural disasters or factors such as policy changes or physical displacement. (Does not include seasonal or project-based workers).

Research Study Partners:

- Mount Waddington Family Literacy Society (MWFLS) Local Project Lead
- Decoda Literacy Solutions Provincial Project Lead
- <u>Social Research and Demonstration Corporation</u> (SRDC) will design surveys and conduct literacy review, focus groups & surveys
- Learning Metrix will manage project data

Outreach Team Role: Outreach Team members will help identify workers, employers, and government and community service agencies who are affected by worker displacement. They will provide input on local impacts, whether existing programs are effective, and what gaps exist in the current system. They will also investigate local employer needs.

Team members will meet with SRDC for an in-depth discussion of local displaced workers.

Time Commitment: Participation will initially consist of attending a half-day meeting within the region (agenda and "save the date" to follow), completion of a survey, as well as additional follow up calls.

Information Items

2020 Annual General Meeting

On January 18, 2020, Vancouver Island Regional Library (VIRL) Board of Trustees convened for the 2020 Annual General Meeting (AGM). The Board received an orientation for new and returning Trustees, learned about VIRL's Advocacy efforts and goals, and how VIRL is "not your typical library."

Trustees also toured the Creativity Commons and gained firsthand experience of the 21st Century library through a series of technology-related tasks.

VIRL's Board of Trustees visited the Creativity
Commons for a chance to try STEAM (Science

stations, most of which are available to their
communities - rural and urban.

Not Your Typical Library

In many ways, VIRL is unique from municipal libraries and even other regional systems. Our wide and varied geographic jurisdiction, our mix of urban, rural and remote communities, and the high number of branches in our system are some factors that set VIRL apart. In this presentation, the Trustees learned about some of the important initiatives and projects from 2019, including:

- An explanation of our pooled budgeting system
- Our floating collection
- Our diverse array of free programming
- The elimination of children's fines
- The launch of our video game collection
- Our award winning Indigenous Voices program
- The launch of cultural literacy kits
- Opening of new and renovated facilities in Parksville, Sidney/North Saanich, and Sayward
- Our revamped Creativity Commons (which the Trustees had an opportunity to experience on a field trip)



Advocacy Presentation

The purpose of this insightful presentation was to help our Trustees understand the many organizations, provincially and federally, focused on advocating on behalf of municipal and regional library systems in Canada, how VIRL has been involved, and a roadmap for the path ahead.

In 2019, advocacy efforts focused on increasing funding for libraries and raising awareness about restrictive practices being imposed on libraries from major publishing companies related to lending eBooks and eAudiobooks. The Canadian Urban Libraries Council launched a campaign to bring these challenges to the national level and VIRL was actively involved through letters to our Federal candidates during the election, a meeting at the Legislature with the Minister of Education, and from the nearly dozen communities and regional districts that signed a statement of Equitable Access to eBooks.

The Board will continue to be apprised of ongoing advocacy opportunities and campaigns as they arise.



Creativity Commons

Field Trip

As part of the Trustees' orientation about all of the amazing and cutting-edge technologies and resources at VIRL, staff set up a field trip to the Creativity Commons at the Nanaimo Harbourfront branch to provide Trustees with firsthand, tactile experiences with the following:

- Virtual Reality
- 3D Printing
- STEAM Resources, such as Felting and Tech Boxes
- Gaming/E-sports
- Recording Studio





Finance

Finance Report

Balance Sheet: The balance sheet of \$33.0 million shows a healthy balance of cash and investments of \$5.8 million at the end of December and a year to date operating deficit of \$2.9 million.

Revenue and Expenditures: The deficit is due mostly due to an appropriation related to an MFA borrowing, as there is a timing difference between the capital costs being incurred and the repayment of the long-term borrowing. Other than this, revenues were generally in line with expectations and expenditures were within budget. Appropriations to reserves are recorded on a monthly basis. Transfers from reserves are recorded when the expenditures have been substantially completed and adjustments will be made for reserve-funded projects at year end.

Summary: VIRL's finances indicate that results are in line with expectations and significant projects are currently either complete or underway.

Reserves Report

The Board of Trustees is provided with updated reserves information at each meeting. At the end of December, the reserves stood at a balance of \$6.2 million. Appropriations to reserves are recorded on a monthly basis. Year to date withdrawals consist of amounts for debt servicing and projects at Parksville, Sayward, Sidney, Sooke, Chemainus and others, as well as purchases of furniture and equipment, replacement of a delivery vehicle, and investments in IT software and hardware.



The community came to celebrate the opening of the new Sayward branch, which held its Official Opening on December 21.

Facilities Update

Campbell River: VIRL has selected the site of the current branch on Shoppers Row for the new branch. The next step is to work with the Strathcona Regional District to secure funding through the Municipal Finance Authority.

Chemainus: The branch opened to the public on January 13, 2020 to widespread acclaim. Grand Opening celebrations are slated for March 7.

Courtenay: VIRL has initiated planning this project and we await an announcement from the Investing in Canada Infrastructure Program grant.

Ladysmith: Ladysmith is looking to initiate a mixed-use project on property owned by the town, which could include space for a new branch. No recent discussions have taken place.

Masset: VIRL is moving forward with the floorplan and other planning documents for the Masset branch. We await an announcement from the Investing in Canada Infrastructure Program grant.

North Saanich: The proposed site at the Panorama Centre is part of the Agricultural Land Reserve. VIRL awaits further direction from North Saanich.

Port Alberni: VIRL has selected Lowe Hammond Row to complete the architectural work. Project planning will commence shortly.

Sandspit: Discussions are on hold while VIRL and SD50 work to resolve an issue surrounding use of the space.

Sayward: The first of VIRL's prototype branches opened to the public on December 18 with Grand Opening celebrations three days later on December 21. The response from the community has been overwhelmingly positive.

Sooke: The Development Permit was approved by the District of Sooke on November 25 and VIRL has submitted the Building Permit application.

Tahsis: VIRL continues discussion around potential sites or other options for service delivery.

Tofino: VIRL awaits direction from Tofino as to the placement of a new branch.

Woss: The Village of Woss has identified the site for the new branch. VIRL staff have commenced with the necessary planning work in preparation of a prototype branch, including work to produce a bid package.

Purpose

To ask that the City of Port Moody Write to the Federal Government in support of the implementation of a national pharmacare strategy as a priority following the 2019 election.

Recommendation

WHEREAS, The over 3 million Canadians, including many in our local communities, don't take medicines prescribed by their doctors because they can't afford them; and WHEREAS, Canada is currently the ONLY country with a National Medicare Program that does not have a National Pharmacare Program; and

WHEREAS, The risk of having no insurance for medicines is high among lower income Canadians which includes the service industry, precarious working and seasonal workers; and

WHEREAS, The studies show that adding a National Pharmacare Program to our National Health Care System would lower costs to businesses by over \$8 billion per year, providing Canadian companies competitive advantages in international trade; and WHEREAS, The recent research confirms that these gains can be achieved with little or no increase in public investment; and

WHEREAS, Municipal government expenses for employee benefits would be significantly reduced by a National Pharmacare Program; and

AND THAT this letter be forwarded to all BC municipalities asking to write their support as well.

Background

In 2017, the City of Port Moody wrote to the federal government to support the development of a Nation Pharmacare program (attachment 1); this has been initiative supported by the majority of Canadians, but it has yet to come to pass despite support from at least three major parties. Growing health and wealth inequalities impact Port Moody residents, including a growing elder population; BC residents may be hardest hit by lack of universal coverage, despite recent changes to provincial drug coverage, as demonstrated in a 2018 cross-institutional study https://www.myprincegeorgenow.com/68282/bc-residents-struggling-afford-prescription-drugs/. Studies have shown that 88% of Canadians support universal medicare as a component of our universal health care system, as was summarized in a brief to the house of commons https://www.ourcommons.ca/Content/Committee/421/HESA/Brief/BR8352162/br-external/AngusReidInstitute-e.pdf.

As Port Moody moves into budget season, it makes sense to push for policies from other sphere of government that will take pressure off of our residents, and indeed off of our corporate coffers, as studies from the Columbia Institute and Canadian Doctors for Medicare have calculated that local governments across Canada would save millions if such a system was in place, which is why it has been endorsed by the Surrey Board of Trade and the BC Chamber of Commerce.

Now is an opportune time for local governments to remind the federal government that a national pharmacare strategy needs to be a priority.

Discussion

Writings from the <u>Canadian Labour Congress demonstrate why national universal pharmacare</u> would benefit our residents, our city as a corporation, and small businesses:

Finally, some good news for <u>the millions of Canadians</u> who have to choose between paying for groceries or their prescription medications.

Canada's Advisory Council on the Implementation of National Pharmacare has laid out a clear path for public, single-payer, universal pharmacare in its **final report**.

"The time for universal, single-payer, public pharmacare has come," writes Dr. Eric Hoskins, the Council's chair. "This is our generation's national project: better access to the medicines we need, improved health outcomes and a fairer and more sustainable prescription medicine system."

This is the unfinished business of medicare, as envisioned by the late Tommy Douglas. As Saskatchewan's seventh premier, Mr. Douglas pioneered North America's first universal, single-payer health care system. It would become a cornerstone of Canada's social safety net and a key pillar of our nation.

We know that a fair society must be one in which every person has the opportunity to succeed and to thrive... we believe that universal, public pharmacare is a necessary step towards greater fairness.

As <u>numerous studies</u> have shown, millions of Canadians are struggling to afford to pay for their prescription medications. One study found that nearly a million Canadians sacrificed basic needs such as food, and close to a quarter of a million people gave up heating their homes. This lack of affordability is hurting not only people's health and well-being, but the <u>economic strength of our communities</u>.

The new report demonstrates that every family will save, on average, \$350 per year on medications. It also points out that the average business owner will save about \$750 per employee. That will open up capacity for businesses to increase wages, or expand other types of coverage, including for dental and vision care. It also supports small businesses that find it difficult to compete for workers when they can't afford to offer drug coverage.

There will be an upfront cost, specifically at the outset, but as time goes on, the money our provincial health care systems will save will be significant. A **recent study** found that over 300,000 people had additional doctor visits, 93,000 had to go to the emergency department and 26,000 people were admitted to hospital – all because they couldn't pay for their medications. That creates a significant burden on the health care system, one that we can alleviate with a national drug plan.
