Dear Mayors and Regional Chairs:

I am pleased to let you know of the significant investment our government has made to support all our municipalities and regional districts around the province. This is in direct response to my mandate letter to support growing municipalities and regional districts with funding for infrastructure and community amenities.

Today Premier David Eby and I announced the B.C. building stronger communities with \$1-billion Growing Communities Fund | BC Gov News. The fund will provide a one-time total of \$1 billion in direct grants to all 188 of B.C.s municipalities and regional districts. Your local government can use it to address your community's unique infrastructure and amenities demands, such as recreation facilities, parks and water treatment plants, as well as other community infrastructure. It will help communities prepare for future growth and build the amenities needed to support new home construction, especially with the Housing Supply Act where targets are set.

These grants will complement existing infrastructure funding programs for projects such as sewer, water and recreation facilities. The province will distribute them to B.C.'s 188 municipalities and regional districts by the end of March 2023. The Growing Communities Fund arises from the surplus shown in the Second Quarter Financial Report. The province is putting this year's surplus to work for people to support them now and for the long term.

The province has heard from local governments about the need for infrastructure and amenities to support their growth. Infrastructure funding programs are routinely significantly oversubscribed. For example, there were six times more requests for funding through the "Investing in Canada Infrastructure Program Community Culture and Recreation" stream than what was available. This one-time fund also supports priorities identified by the Union of British Columbia Municipalities (UBCM).

The Ministry will issue a direction letter to each local government in March 2023 including further details on this one-time direct grant. This will include information on the formula used to allocate the funds, the amount your local government will be receiving and the province's expectations for the use and reporting of the funds.

As this is a direct grant from the province to each municipality and regional district in B.C., your local government will not have to apply for the funds. Your council or board will be required to make decisions on the use of the funds in compliance with this second letter coming in March 2023. Projects that support neighboring First Nations communities are strongly encouraged.

With many new municipal mayors and council members elected and now sworn in across the province, I wanted to reach out and let you know how the Office of the Ombudsperson can work with, and help, local governments in British Columbia.

If you are continuing in your elected position, thank you for your service to British Columbians. And if you are newly elected, welcome to your very important role.

My office takes complaints from the public about all of the local governments in BC. We are an oversight body, one of the independent offices of the Legislature, and our mandate is to be BC's independent voice for fairness and accountability of the public sector. When we receive people's concerns about public services, we conduct impartial investigations and address the fairness problems that we find. For local governments, that means you may hear from us when we have received a complaint about your municipality and are investigating to determine whether the standard of fair and reasonable service set out in the *Ombudsperson Act* has been met. Where fairness issues are identified, we can consult with you to find a way to address the issues in order to ensure fairness moving forward.

We are also available to help. Our <u>Public Authority Consultation and Training team</u> can assist you with any questions about fairness you may have. A number of <u>useful resources</u> are also available on our website, including:

New Rural Advisory Program Announced by Island Coastal Economic Trust, with support from the Province of B.C.

One-year program will fund Indigenous and rural communities to support local businesses



The new Rural Advisory program opens for applications on February 20, 2023.

COURTENAY, 9 February 2023 – Island Coastal Economic Trust announced the Rural Advisory program today, supported by the second round of funding for the Province of British Columbia's Rural Business and Community Recovery Initiative. The Rural Advisory program will provide funding for new community-based and regional business advisors to support Indigenous and rural businesses and communities impacted by forest policy changes and other economic effects on the forest sector.

"The forestry sector has been at the economic heart of many coastal communities for generations," says Aaron Stone, Chair, Island Coastal Economic Trust. "This partnership with the Province comes at a crucial time — we need to shift from high-volume to high-value and find new and innovative ways to transition, diversify, and adapt these economies while safeguarding the jobs of community members and the ecological integrity of our forests."

Island Coastal Economic Trust will open the Rural Advisory program to applications across its service region on February 20, 2023. Two funding streams are available:

- Community-based Advisors 15 available grants of up to \$70,000 for Indigenous and rural communities to create a one-year term position that provides community and/or business advisory services; and,
- Regional Business Advisors three available grants of up to \$100,000 for non-profit business consulting and/or financial services organizations to create a one-year term position that provides specialized and/or sectoral business advisory service.

Advisor positions will support local businesses and communities in their economic diversification and transition process. Services provided will focus on the impacts from changes in forest policy and other economic effects on the

forest sector.

"By funding a new round of advisor positions, we're ensuring rural communities and businesses have access to the supports and help needed as they transition toward building sustainable, resilient economies," said Brenda Bailey, Minister of Jobs, Economic Development and Innovation. "We are appreciative of Island Coastal Economic Trust's continued efforts to support inclusive economic development, diversification, and innovation led by Indigenous and rural communities across Vancouver Island and the coast."

The new Rural Advisory program builds upon the successes and learnings from a previous partnership between the Province of B.C. and Island Coastal Economic Trust that invested in rural economic development recovery from the pandemic. Under the prior program, 37 rural recovery advisors directly secured over \$15 million of new investment into economic development and diversification priorities in rural communities across Vancouver Island and the coast.

"With the closure of our pulp mill and the uncertainty in the fishing and forestry industries it is even more crucial for us to explore economic development opportunities," says Bonnie Danyk, Chief Administrative Officer, Village of Port Alice. "Without the funding from Island Coastal Economic Trust and the Province under the 2021-22 Rural Recovery program, we would not have been able to hire Ryan Nicholson, our Economic Development Coordinator, which would have been a huge loss to the community."

The Province is providing \$1.5 million to Island Coastal Economic Trust to deliver the Rural Advisory Program. This is part of a total \$4.5 million commitment by the Province of B.C. being delivered across the province by Island Coastal Economic Trust, Northern Development Initiative Trust, and Economic Trust of the Southern Interior.

New pre-health program to help fill Island health care gaps


A new dedicated university-level pathway at North Island College will help make it easier for students to pursue careers in the medical and health sciences.

The Island Pre-Health Science program was developed in response to the growing demand for health science and medical professionals across the region. Applications are open now, with the first intake starting in September.

The program is a jumping off point for students wanting to pursue a professional degree in medicine, dentistry, pharmacology, chiropractic practice, optometry, health science research and other related areas.

Vincent Michaud is preparing to go into medicine and is in his second year of courses at NIC. The new program, he says, will help others like him wishing to do their prerequisite work closer to home.

"It would allow me to stay in my local area longer and strengthen ties with local partners before starting my medical practice, which would improve my desire to come back here as a doctor," he said. "The community of students it would form would allow me to

interact with like-minded peers and form study groups for various extracurricular tests like the Medical College Admission Test."

A key feature of the new program is to have students learn about the communities around them and form deeper roots. The program will provide students with a rural and Island framework to identify challenges and opportunities in North Island communities. It will also include Indigenous ways of knowing and methodologies.

"The new program combines place-based learning with university-level courses that prepare students for degree completion in health and medical sciences," said Dr Neil Cruickshank, Dean, Faculty of Arts, Science & Management. "The curriculum is designed to provide a holistic understanding of health science and issues unique to rural, remote communities. Combining foundational science courses with social scientific approaches, Indigenous ways of knowing and, a community-learning strategy, students will gain incredibly valuable, transferable skills and knowledge."

Students can graduate with an Advanced Diploma after three years of full-time study. The program will be based in the Comox Valley, with a mix of lecture-and-lab, lecture-and-tutorial and lecture-only courses. A program support person will help students and the development of integrated learning opportunities.

One of the driving factors for NIC in creating the program is the need for more medical professionals. For example, the Comox Valley alone has an estimated 17,000 individuals who lack a primary care provider. Over the next decade, the demand for health care professionals is only expected to increase.

"Primary care is at a critical juncture in BC, especially in our rural communities. By engaging new learners, early in their training, we have an opportunity to support and build capacity for the next generation. An Island Pre-Health Science

program would allow us to share our experiences of a health care career in our own community," said Dr. Glenn Kisman, a Comox Valley family physician.

The program will begin in Fall 2023. A virtual information session will be taking place Thursday, Feb. 23 from 7-8pm. To learn more about the program and the info session, visit www.nic.bc.ca.
