Subject: Public Works Monthly Report

Well #3 is online and working fine. We just wrapped up a significant water repair on Taylor way, we had to shut down water to large swathes of town and keep a hydrant running just to isolate the area to complete the repair. The vast majority of our intersections only have one isolation valve, where if we had 3, we could isolate the effected area only. I recommend to council we continue to try and go after grant funding to fix the entire system or upgrade intersections. This latest fix will effectively wipe out our paving budget for this year unfortunately. Some shallow intersections we could do in house however deeper ones will require the proper safety equipment (cages) in order to keep the hole small and reduce asphalt costs. Either way significant funding will be required. We successfully installed 6 new street lights on Haida Ave and down Nigei street to the school. The weather has been perfect for growing grass, Gord Doleman, our on-call guy, has been a huge help this year filling in for guys gone on vacation leave etc... allowing us to knock off some overdue projects as well with the extra help.

#### Water

- -Water samples taken to Port McNeil.
- -Well #3 is officially online.
- -Wells were checked and meters read daily.
- -Fixed water main break on Taylor Way.

# Sewer Sys/ Treatment Plant

- -Effluent samples were shipped to Courtney monthly.
- -Regular daily/weekly maintenance was performed for STP.
- -Lift stations were cleaned and inspected weekly.

### **Transfer Station**

- -Transfer Station was cleaned daily/weekly.
- -Garbage cans in town were cleaned(weekly)
- -Hauled 2 loads of recyclables (E-waste, cardboard, tires) to 7-mile.
- -Hauled 2 blue bin of garbage to 7-mile.
- -Hauled 1 metal bin.
- -Hauled 2 wood bin.

#### **Equipment**

- -Generators were tested(monthly)
- -Weekly inspections carried out on Play structures/Parks/Marina/Water Tanks
- -Full service on Back-hoe

# **Roads**

-Installed 6 street lights.

# **Facilities**

- -Fixed light switch at Community Centre.
- -Ran Generator for Community Centre.
- -Canada Day preparations.

# **General**

- -Cut grass.
- -Weed eat.
