On behalf of the Ministry of Energy and Climate Solutions (Ministry), I am writing to inform Village of Port Alice that the Ministry has brought forward legislation (Bill 3125) to amend the Utilities Commission Act (UCA) to:

- Expedite the construction of the North Coast Transmission Line in partnership with First Nations, advancing economic growth and reconciliation;
- Ensure electricity is available for sectors that produce jobs, generate public revenues, and have the greatest opportunity to decarbonize, including mining, upstream natural gas, liquified natural gas and manufacturing; and
- Enable a process for emerging sectors such as data centres, artificial intelligence (AI) and hydrogen to grow in a manner that results in the greatest benefits to people in BC and the economy.

On behalf of the Ministry of Energy and Climate Solutions (Ministry), I am writing to invite Village of Port Alice to participate in a province-wide engagement on the development of regulations related to Bill 31 pending its passage through the legislative assembly. Specifically, these regulations are to implement an electricity allocation framework which would govern how AI facilities, data centres, and certain hydrogen production plants receive electricity.



Dear Municipal Leaders,

On October 23, 2025, Canada's new government introduced the *Bail and Sentencing Reform Act*. The bill is a comprehensive package of reforms to strengthen community safety and restore confidence in our justice system.

Canadians deserve to feel safe in their homes and neighbourhoods. Too many communities are seeing repeat, violent offenders cycling in and out of the system. This legislation responds directly to those concerns, with more than 80 targeted changes to the *Criminal Code of Canada* designed to make bail stricter, strengthen sentencing, and enhance accountability.

Key reforms include:

- Stronger bail laws to ensure that individuals charged with serious or violent offences are not automatically released back into communities while awaiting trial.
- Tougher sentencing provisions to reflect the gravity of repeat and violent crimes, including new aggravating factors for offences such as organized retail theft and damage to critical infrastructure.
- Support for prevention and enforcement, through investments in policing, social housing, mental health, and addictions services that help address the root causes of crime.

These changes uphold the *Charter of Rights and Freedoms* and the presumption of innocence. What is changing is how our justice system deals with serious and repeat criminal behaviour, by strengthening bail, increasing accountability, and prioritizing public safety.

This legislation is part of a broader, three-pillar plan to build safer communities:

- 1. Stronger laws targeted reforms to the *Criminal Code* to hold repeat, violent offenders accountable.
- 2. Stronger enforcement resources for provinces, territories, and police to ensure laws are properly applied and conditions enforced.
- 3. Upstream supports investments in prevention, housing, mental health, and addictions that address the root causes of crime before they escalate.

Subject: Quatsino Chalet Annex

On October 7, 2024 the Quatsino Chalet Annex located at 1113 Nigei Street was auctioned at the annual tax sale. There were no bidders on the property, so the Village of Port Alice was deemed the purchaser. The one- year redemption period for the tax sale ended on October 7, 2025 and the property was not redeemed. I am currently in the process of transferring the title to the Village of Port Alice.

The Village of Port Alice Council will need to decide if they would like to sell the building at market value or if they want to renovate it and use it for housing. There is a strong need on the North Island for both subsidized Seniors housing and employee housing for health care and service sectors.

I would recommend that one of the first tasks to be done is a condition assessment on the building. This will give us a baseline of what will need to be repaired immediately as well as an understanding of what services are shared with the Quatsino Hotel (heating, hydro) and what the process would be to sever them. The Village should also work on making the building more secure and consider adding an alarm system.

If the Village decides to keep the building and renovate it for housing, we will need to figure out how to fund it. Current programs such as the Federal Government "Build Canada Homes" and the CMHC "Affordable Housing Fund" are for new builds only. CMHC has a "Apartment Construction Loan Program: Seniors Rental Housing" but there is a minimum of 50 units required. There are funding and loan programs with a strong focus on green infrastructure available through the Federation of Canadian Municipalities. BC Housing may also have funding programs or partnerships available. Once the condition assessment is done, these programs can be researched more thoroughly to see what available options are.

NIC hosts resource fair to support youth with disabilities transitioning to adulthood

COURTENAY, BC - Navigating the path to adulthood can be challenging for any young person. To help youth with disabilities and their families find the right supports, North Island College's Accessible Education and Training (AET) department is hosting a Community Resource Fair. The fair is an opportunity to connect with local organizations that promote independence, learning and belonging.

The event, taking place November 24 (1:45-5pm) at the college's Stan Hagen Theatre, will bring together a range of local organizations, including the Ministry of Children and Family Development (MCFD), Community Living BC (CLBC) and several others. Attendees will have an opportunity to learn about available resources and explore post-secondary options that support an independent, meaningful adult life.



NIC Comox Valley is set to host a resource fair to support youth with disabilities transitioning into adulthood.

"The transition to adulthood is a big step," said Liz Girard, AET instructor and chair. "This fair brings people together to learn, ask questions and find the supports that fit their next stage in life."

The afternoon will also feature a presentation from self-advocate Sherwin Strong, who is from the Nuchatlaht and Carrier First Nations. Strong, who is also a Comox musician, will share his experiences of overcoming adversity and living as a self-advocate.

Additionally, NIC students in the AET program will display posters reflecting on their own journeys from teenage years to adulthood, while students from School District 71 will showcase art on the same theme.

The event is also supported by the college's nursing students, who are helping organize the fair and connect with participants as part of their community health studies.

"It's exciting to bring so many supports together in one place," said Tanisha Steven, a fourth-year Bachelor of Science in Nursing student. "We hope people leave feeling more connected and aware of the opportunities around them."

North Island College's AET department offers courses for students supporting them in developing personal, academic and employment skills. AET students explore pathways to meaningful employment, with graduates going on to work in areas such as retail, food services, animal care, landscaping and more.
